Angelina made the motion to approve the November financial report. Buffie seconded the motion. The Council members approved the financial report.

#### Review and Approval of 2024 Budget

Discussion of the 2024 budget. Our goal for pledges for 2024 is \$200,000. The 2024 Pledge total as of 11/23/2023 is \$179,077.60. By using our usual formula (9.2% of Pledged funds) for estimating our non-pledged donations, we are expecting \$19,800.00 for 2024. The combination of Pledged and estimated non-pledge donations total \$199,800. Total expected income is \$214,135. Total projected expenses are \$211,096 (following the adjustment mentioned below) for a net income of \$3038.

The 2024 Budget projection of groundskeeping was \$3,000. It was suggested to change this to \$3,6000 which would reflect what our typical expenses would be for the year (\$300/month).

Buffie made the motion to approve the 2024 budget with the amendment to the groundskeeping expense to \$3,600. Rev. David seconded the motion. The Council members approved the 2024 budget.
