## **Consent Agenda**

#### **Approval of Minutes**

Buffie made the motion to approve the December 19, 2023, Council meeting minutes as revised by Rev David. Kathy seconded the motion. The Council members present approved the minutes.

## **Mobilizing Our Mission**

#### **Groundskeeping Update**

The custodian now has a leaf blower and rechargeable battery for leaves and small branches on sidewalks and parking area.

With winter weather, it will be important to make sure the snow is removed, and that Ice Melt is on sidewalks, steps, and ramps.

The Custodian will be able to call Rev. David or Council member liaison to discuss if the snow is too deep or it is too icy for holding services.

With winds there are branches that will be down, who will be taking care of these? Discussion on having a person that is bonded doing roof clearing and gutter cleaning.

The partners will be discussing the roof cleaning and if they decide not to do this themselves, they may hire out for this service.

#### Pizza and Participation – find a new 'champion' or new date All

Jenn is not available and cannot be lead for this event.

Buffie will take lead for the Pizza and Participation for Feb.11<sup>th</sup>.

The Budget for the event is \$400.

Pizza has been purchased from a local pizza restaurant like Old School Pizza. It was mentioned that Vic's has a South Bay location now.

Discussion of how to demonstrate the number of people that are volunteering time and service to the center.

Following that, community members can have conversations with the service team leads about what each volunteer position entails and sign-up for the positions that fit their talents and interests.

#### Publicly thanking people for their service

Discussion on the type of recognition that would be given for the different positions.

Council members will receive a plant and thank you card.

Denny has done Sunday service slides for at least 12 years and Carol has led Compassionate Care for a long time

There will also be a written or frameable recognition document.

Caroline Fenn is stepping down from Prosperity Stewards.

#### Things that need to be done

Kathy will get the Secretary boxes from Beth.

Tiffany will bring in the file box and misc. office supplies that transitioned to her when she took over the administrative assistant role.

Rev. David will purchase a "Service animals only" sticker for the front door.

Tiffany will ask Sandy to add a note to the online FAQs that no pets are allowed only service animals.

#### Potential rentals (Threshold Singers and Senior Yoga class) Tiffany

Discussion of building rental pricing when members are renting for Memorial services.

Council decided that Memorials would be a \$50 flat fee for the use of the building for members of CSL

Olympia. The A/V tech and custodian fees could not be reduced because they are not discretionary costs.

Member rentals for other events can have a 20% reduced fee for room rental and use of dishware. There cannot be a reduction in the A/V tech and custodian fees.

Discussion of hosting other events that benefit the members. Tiffany will follow up with the person that is interested in having senior yoga at the center. The room could be rented with no cleaning fee and no use of the kitchen. More information is needed before a decision is made.

Discussion on having quarterly events that would bring people from the community to the Center such as musical entertainment.

Angelina mentioned the Peace Singers (a branch of the Peace Choir) might be a possible group to book.

Ideas generated for types of entertainment were jazz, blues, bluegrass music, and theater.

This topic will be discussed at the first meeting in February.

#### Nourishing Our Community (NOC) 2024 discussion-finding a leader/champion

The bidding for events usually begins in March and lasts about 3 weeks.

Kathy will be the Council liaison for this project.

Discussion of potential co-chairs and others that could be approached for working on this project. Christi and Lynn Edele may be interested in being co-chairs. Shelly, Jody, and Stacey may also be interested in working on this project. The Council members divided up the names and will approach these people to see if they are interested in working on this project. A general call for volunteers will also be made to the membership.

Discussion of timeline for planning:

February is the month that we will need to find hosts for NOC events. Tiffany can be the contact for hosts in February.

In March and April there will be three-weeks designated for bidding on the NOC events.
